

# 2018 Hotel Trades Council Division 'A' Scholarships Eligibility Information Form

Applications are now available for the 2018 Hotel Trades Council Division A scholarships. The program is open to children of eligible members of the New York Hotel Trades Council who are employed in eligible Division A hotels. A list of eligible Division A hotels appears at the bottom of this form. Applicants must be graduating high school seniors who are planning to attend an accredited four-year college or university in the fall of 2018. Only children of HTC members employed in Division A hotels are eligible for Division A scholarships. Children of HTC members employed in non-Division A hotels may be eligible for Vito J. Pitta scholarships. An Eligibility Information Form for that program also appears in this edition of the Hotel Voice magazine

To find out if your child is eligible to apply for a Hotel Trades Council Division A scholarship, you must complete the following Eligibility Information Form below and submit it as soon as possible and no later than Monday, April 2, 2018. You may mail the completed form to the address listed below.

an application for the Hotel Trades Council Division A scholarship program! As soon as your information is reviewed you will be advised immediately. If your child is eligible for a 2018 Hotel Trades Council Division A scholarship, an application will be mailed to you.
